WORK SESSION MEETING**

**CALL TO ORDER**

**JANUARY 26, 2018**

Chair Tim Sather opened the Building Committee Work Session meeting at 12:03p.m. and began with leading those present in the Pledge Allegiance.

The following trustees/committee members and officers were present: Trustees Tim Sather, Pamela Ask, Scott Kiecover, Superintendent Tobin Novasio and District Clerk Laurie Noonkester. Collaborative Design Architect Nick Pancheau, Evelyn Pyburn with the Yellowstone County News and Matt Hoffman with the Billings Gazette were also in attendance.

The Building Committee/Trustees met in a work session to review the information gathered from the High School Community Meeting held on January 24, 2018.

Items reported upon where:

1. Feedback from Community Meeting – Site short list was reviewed and cost breakdown for each site noted.  
During a recent Yellowstone County Commissioners meeting it was suggested Site A is the most logical choice considering countywide issues. Those community members attending were asked to vote their site choice at the Community Meeting, resulting with site A being the overwhelming popular choice. All notes from these meetings are posted upon the Lockwood High School Page located on the Lockwood School webpage.
2. Site Selection Discussion- Cost, square footage and student population discussions were held. The Trustee Building Committee directed Collaborate Design to focus efforts on Site A in light of community input and cost feasibility.
3. Programming Discussion – Architect Nick Pancheau asked for direction regarding specific district needs for multi-use buildings use such as auditorium and commons areas. He presented preliminary image designs and the vote tally for each image received from the community meeting. Gymnasium seating of 3,500 to 3,100 is being investigated currently as well as a stadium with seating capacity at 4,500, which is similar to the stadium size at Laurel.

4. Next Steps – Building Committee Meeting to bring proposed building layout and design to include initial cost estimates will be held next Friday, February 2, 2018 at 12:00 p.m.

The meeting was adjourned at 1:31 p.m.
